Technical assistance required to train the staff needed to set up the single window, particularly with regard simplification processes, and to help transfer the knowledge needed to update the competent national authorities and help them to adapt to the new system. Purchase of information and communication technology equipment as well as other types of equipment. There has been a feasibility study and a project by UNCTAD dating back to August 2014, but there are no donors to help implement them.

Progress reported

Cuba, Sistema de Ventanilla Única Electrónica para el Procedimiento de Comercio Exterior:
En 2014 se solicitó oficialmente a la UNCTAD un proyecto para para la implementación de la estrategia de desarrollo de la Ventanilla Única electrónica de Comercio Exterior (VUCE), bajo el requisito de que serían adjudicados los fondos financieros por la cooperación internacional. La Unión Europea asignó los fondos de esta Cooperación en julio de 2019.

A partir de ese momento, el Ministerio del Comercio Exterior y la Inversión Extranjera (MINCEX) desarrolló, bajo la asistencia técnica de la UNCTAD y de conjunto un cronograma de trabajo para documentar, clarificar y la simplificación de los procesos de registros, permisos previos y despacho, mediante el desarrollo de seminarios sobre implementación de un sistema de ventanilla Única. Se ha recibido capacitación por parte de expertos de la UNCTAD.

En marzo de 2018 se recibe el Derecho de Uso del "Sistema eRegistration" el cual fue hospedado en un servidor nacional. El logro más significativo durante el año 2019 fue finalizar la documentación de esta plataforma a partir de la asistencia técnica recibida de la UNCTAD. La plataforma tiene documentada 125 normativas, 108 trámites de 41 organismos, instituciones o Autoridades Nacionales Competentes.

En septiembre de 2019 quedó implementado por el MINCEX y la UNCTAD un mecanismo de autenticación para el "Sistema eRegulations" nombrado "Central Authentication Service (CAS)".

Se presentó por parte de la UNCTAD el Prototipo VUCE Fase I, para lo cual se acordó el primer servicio automatizado a desarrollar hasta enero de 2020 por la integración de los registros del MINCEX, la Cámara de Comercio de Cuba y la Aduana General de la República (AGR), ejecutándose un análisis del servicio integrado en línea.

Se acordó crear la Base de Datos Postgre de la Cámara de Comercio de Cuba, comprar un servidor para esta institución y desarrollar los servicios web de Ventanilla Única en el MINCEX, la Cámara de Comercio de Cuba y la Aduana General del República. También se acordó un Formulario Único de Ventanilla Única.

Se decidió integrar la Pasarela de Pago ENZONA a la Ventanilla Única

Quedó acordado el desarrollo de "Web Services" con la Oficina Nacional de Administración Tributaria (ONAT).
