Assistance required for implementation

- 1. Technical assistance and support for changing/adapting legal framework in order to harmonize the border authorities' processes and procedures for pre-arrival processing;
- 2. Assistance and support for trainings and capacity building for border customs and inspections officials regarding the processing of declarations and documents prior to arrival of goods;
- 3. Assistance and support for trainings for business entities on benefits and manner of use of this system;
- 4. Technical, IT and financial assistance and support for development of the Customs Information System's (CIS) software module for the automated processing of declarations and documents prior to the arrival of goods;
- 5. Assistance and support for acquisitions of necessary IT equipment for border inspections, introduction of an IT system within the inspections and its networking with the CIS.

- 4. Technical, IT and financial assistance and support for the upgrade of CIS to support pre-arrival processing and expedited release of perishable goods.

- 5. Technical assistance and support for conducting business process analysis and re-engineering business process model ("as is to be" model);
- 6. Assistance and support for preparation and implementation of capacity building plan, incl. trainings and recruitment of new staff;
- 7. Technical and financial assistance and support for preparation and implementation of the SW development project (incl. fee model, risk management model, procurement plan);
- 8. Technical, IT and financial assistance and support for creation of an e-platform and acquisition of IT equipment;
- 9. Technical and financial assistance and support for setting up into function Single Window;
- 10. Financial support for the implementation of the "Timestamp issuing system" project the purchase of the system, its implementation, warranty period and support;
- 11. Other technical and financial assistance and support for implementation of Article 10.4.
