Assistance needed:

1. Training and other forms of technical assistance to build the capacity of the human resources of each government agency and other relevant sectors that shall form part of the National Single Window Program.
2. Funding for the development of a program or software that will be used as the operating system for the National Single Window.
3. Funding for the upgrade of the current IT equipment that will be used for the implementation of the National Single Window in all ports of entry and at the facilities of participating sectors and government agencies.
