**Progress reported**

TMEA financed the establishment of a One Stop Shop for Trade Information Repository (Uganda Trade Information Portal) while UNCTAD provided infrastructure and technical assistance to document 55 products (43 exports/12 imports), 348 procedures, Transit -11, 72 Institutions, 39 legal documents and 227 forms for export and import.

ITC supported a few private sector engagements on coffee and cocoa export documents under the EU-EAC-Mark Up project Phase one. Swiss-Contact provided support for capturing data and information on fruits and vegetables sector which was uploaded on the Portal.

Impact: Real time trade information on the Portal, reduced cost and time to search for information, feedback on complaints by users addressed. Five EAC Partner States run similar Trade Information Portals and easily accessible to investors and global exporters. So far 36 of 49 procedures are under simplification, 6 steps eliminated, 29 steps digitalized and 21 documents have been eliminated, 11 hours saved.

Beneficiaries: The General Public, Traders, International business community etc.

Funding Gap: Documentation of other key Products and Services; Funding the communication strategy, Simplification of procedures through the National Trade Facilitation Committee (NTFC) and funding a Secretariat of NTFC to follow up on implementation of the agreement and business community inquiries; automation of different Public digital systems. Sustainability of Trade Information Portal; Change Management of human resources and institutions; Capacity building for the business community and the general public.

#### Progress reported

In 2022, UNCTAD supported a consultant to coordinate efforts of the National Trade Facilitation Committee Secretariat for a period of 6 months and also developed the Reform Tracker Portal for Uganda, an online facility to track Uganda's implementation of the WTO trade facilitation agreement and activities of the NTFCs and the simplification work.

Progress made: Development of technical papers for the technical working groups under the NTFC Committee and capacity building of the UNCTAD reform Tracker.

Funding Gap: The Ministry of Trade, Industry and Cooperatives (MTIC) is the national enquiry point that coordinates all other sectional enquiry points in the country and is also responsible for all trade related notifications under WTO. So, support to provide a robust work in this role and also maintaining a dedicated Secretariat is needed. The meagre funding at the Ministry inhibits the institution from coordinating the trade facilitation initiatives at the national, regional and multilateral levels in an efficient manner.

**Progress reported**

TMEA and European union supported construction of One Stop Border Posts (OSBP) while World Bank provided a credit facility for the construction of some Border Markets. The development support has led to the Construction of five border export zones at Busia, Katuna, Lwakhakha, Mpondwe and Oraba and renovation of the OSPB at Bunagana.

Impact: Coordinated Border Management; Cross Border Trade Association and Trade Information Desks infrastructures strengthened; NTBs Monitoring Committees established. Support for the simplified trade regime and amplifying or formalizing of cross border traders who are majorly women, youth and small and medium enterprises.

Funding Gap: Outstanding construction of OSBPs at Bunagana, and Lwakhakha; Harmonization of working hours with all border agencies (URA, MAAIF, Immigration, UNBS, NDA, and DDA), funding coordination efforts; ICT Infrastructure. Harmonization beyond Uganda borders with other institutions from EAC Partner States. Sustainability of outstanding works, automation of cross border agencies, trade negotiations missions and private sector business engagements. Funding Joint border committees, Capacitating trade information desks and data collection of cross-border flows.

#### Progress reported

TMEA was the funding arm while UNCTAD was the implementing agency which provided the e-Single Window system that integrated other public and private institutions beyond Uganda Revenue Authority and Ministry of Trade, Industry and Cooperatives. The Government of Uganda is currently sustaining some efforts to keep the initiative ongoing.

Achievements to date: Customs clearance time reduced; required documents to process clearance reduced; Private Sector secured licenses of export permits, Reduction in human interface; goods cleared in record time; curb on corruption; electronic access to permits and certificates; licensing clearing agents online; transit certificates digitalized; interfaces with commercial banks; online bids for auctions easily accessible; etc. Funding Gap: The target is to have 45 agencies on the e-Single Window. So far 22 are actively operational on the system. ICT application interface for permits, certificates is needed; Online Advance ruling to be fully automated, online accreditation of Authorized Economic Operators (AEOs), Commodity agency application, Funding communication Strategy, electronic payments. Investment in servers and Source code funding.
